Section 1: Background

The Needle and Syringe Exchange Service (NSES) is vital to the health and wellbeing of the entire community, helping to reduce the potential of drug-related litter, lowering the risk of HIV and Hepatitis B and C within the wider population, and putting those who use the service in direct contact with a health professional who can help them in engaging with treatment services to address their substance use. Thirty-five needle exchange services are commissioned across Northern Ireland based in areas where there is an existing pattern of people who inject, but help protect everyone in the community. Anyone who injects substances can use a needle exchange service, and this includes people who inject opioids, steroids, tanning agents or stimulants.

Throughout 2022 PHA fully implemented a new online database to record needle exchange activity alongside anonymous, non-identifiable client data. This database is called the Neo360 Harm Reduction Information System and became fully operational across all NSES sites on 1 December 2022. This database permits live data to be accessed which in turn will allow for a timely and effective public health response to any detected trends.

This report summarises data that has been collated by Neo360 between 1 January 2023 and 31 December 2023.

In 2023 there have been:

- 6,353 new clients registered on Neo360 to use the needle exchange service
- 7,320 unique clients accessing the needle exchange service. Please note that due to the number of clients re-registering on the system this number is inflated.
- 1,277 clients are crossing Trust boundaries to access needle exchange services
- 7 new exchanges have opened
- 98 needle exchange staff have completed the NSES mandatory practitioners training.

This report includes the regional data across Northern Ireland, followed by a breakdown per Trust, **correct as of 1 January 2024**. The following information is collated:

- Total number of transactions;
- Transaction by provider type;
- Transaction by trust location;
- Age of client at registration;
- Gender of client at registration;
- Recorded substance/s used.

Section 2: Regional NSES Data Review

NSES Transactions

From 1 January 2023 to 31 December 2023 there were a total of **31,851 NSES transactions** carried out across Northern Ireland.

Table 2 reflects the total number of transactions completed per year. Please note that previously the report was completed by financial year (1 April to 31 March), however, since the implementation of the digital recording system reports are now completed by calendar year. Please also see that we have two years where data was not analysed due to the COVID-19 pandemic.

This table reflects that the quantity of exchanges has decreased over the last number of years, however, the quantity of equipment being dispensed continues to increase suggesting that clients obtain more equipment per transaction.

Overleaf, Figure 1 reflects that the community pharmacies completed 50.4% of the overall transactions for the reporting period, followed closely by the community-based providers completing 46% of the total transactions.

Figure 1: Number of NSES transactions by Provider Type





Figure 2: Number of transactions by each Health and Social Care Trust area



The highest number of overall transactions continue took place in BHSCT area (68.5%) and the lowest percentage of transactions continue to take place in the SHSCT area (3.9%). This year we have targeted the SHSCT area and opened a total of 4 new exchanges to improve coverage in this Trust area.

There is substantial variation among how many clients are registered by Trust area.




Figure 3: Number of Clients Registered by Trust in reporting period

The Belfast Trust has 2,416 clients registered which is 38% of the total new clients registered. The lowest number of clients registered was within the Southern Trust which has 472 clients registered (7.4% of total new clients registered).

NSES User Profile




Figure 4: Current Age of new Clients registered in reporting period

The age and gender profile of the 6,353 users registered within the reporting period is shown in Figures 4 and 5.

The most common age category for new clients is 35-39 years, followed by those aged 30-34 years.

Table 3 below reflects that in previous years 31-40 years was also the most common age group also. Age categories are collated slightly differently within the new system and therefore are not included in this table.

■ Female ■ Male ■ Other


Table 4 reflects that NSES has remained a male dominated service for the last number of years. However, there has been a gradual increase in the number of females accessing the service. In 2016/2017 females completed 14.2% of the transactions and in 2023 females completed 20.1% of the transactions.

Figure 6 shows the gender breakdown by Trust of clients registering for needle exchange. Western Trust area reflects the largest number of female clients and the South Eastern Trust area reflects the largest number of male clients. Within the final quarter of the year the number of females accessing needle exchange in the Belfast area increased by 5 percentage points from 12% to 17%.



Recorded Substance Used

Overleaf, Figure 7 shows the reported substances used by clients for each transaction. Clients may have reported more than one substance in response to this question.

Figure 7: Reported Substances Used by Transaction




Figure 7 reflects that of the 31,841 transactions in this reporting period, 40,175 reports of substance used were recorded across 29 substances. This includes those selecting the 'unknown' category which was 7,646 (19%).

Heroin/morphine (11,201) was reported most frequently needle exchange clients. Cocaine powder (9,265) and anabolic steroids (6,996) are the second and third most frequently reported substances, respectively, across the region. The reported usage of cocaine powder has continued to increase throughout the year. In the final quarter

(October to December 2023) cocaine powder was the most reported substance in the Belfast Trust area for the first time within needle exchange.



Although heroin/morphine were reported most frequently during transactions, the number of unique clients using anabolic steroids by far exceeded those using heroin/morphine or cocaine powder.

Reported Route of Administration of Substance

Neo360 gives the client the opportunity to report how they administer the substance used. In over half of the transactions this information was not disclosed (54.7%). Intramuscular injecting was the most reported route of administration (21.1%) followed by intravenous injecting (19.3%). Smoking was reported at 239 transactions, foils continue to be dispensed at exchanges to reducing the harm from injecting.

Frequency of Substance Used

In the following section, information is presented to show how frequently clients used the various substances. Heroin/morphine as well as cocaine powder were most frequently used daily and more than once per day. Anabolic steroids were reported to be used most 3-4 times per week, weekly or occasionally.

Basic principles are that the shorter needles are used for surface vein injecting (arms, hand, feet etc), and the longer ones for deeper veins (legs and groin) and steroids which are intramuscular injections.

The 0.5ml and the 1ml Unisharp are the mainstay of all injecting equipment, they are the shortest and thinnest needles and also the lowest dead space syringes. It is positive from a harm reduction perspective these continue to be used frequently within needle exchange with 320,264 (49.4%) in total dispensed in the reporting period.

NSES dispenses a 2ml starter pack and 2ml standard pack, 5,834 were dispensed in 2023, however, these do not contain needles. Clients then select needles separately, accounting for the high number of single coloured needles dispensed. The highest dispensed single needles are blue (30mm) 144,957 dispensed and green (40mm) 138,437 dispensed with a total of 283,394 (43.7%) dispensed in the reporting period. These are the largest needles and are used for both groin injecting and also for steroid injecting.

Table 8 reflects the number of packs dispensed. Previously only community pharmacy pack dispensing was collated and, comparatively, there has been a reduction in the amount of packs dispensed. This could be explained by the introduction of the self-select model which allows clients the opportunity to select from loose equipment, tailoring this to exactly what they need as opposed to premade packs.

Use of Foils

In promoting harm reduction, staff within needle exchange sites are encouraged to dispense foils which will support smoking, thus, reducing the harm caused through injecting. Twenty-three sites dispensed 6,505 packets (20 per pack).

Returns

During the reporting period, 67,483 estimated needles were returned within exchanges.

The table below shows previous data collated on returns. The count was previously done by number of sharps bins returned.



In the Belfast Health and Social Care Trust Area (BHSCT) within the reporting period there were:

- 21,819 NSES transactions completed;
- 3,746 unique clients using NSES;
- 2,416 new clients registered for NSES;
- 520 anonymous transactions completed.




Figure 11: Gender of Clients at registration in BHSCT

The majority of new clients registered were male (86.2%).






Figure 12 reflects that of the 21,819 transactions in this reporting period, 29,100 reports of substance used were recorded across 25 substances. This includes those selecting the 'unknown' category which was 3,334 (11.5%).

The largest recorded substance used in needle exchange was heroin/morphine (9,749), followed by cocaine powder (8,745) and anabolic steroids (3,291).


Section 4: Northern Health and Social Care Trust Area NSES Data

In the Northern Health and Social Care Trust Area (NHSCT) within the reporting period there were:

- 4,300 NSES transactions completed;
- 1,898 unique clients using NSES;
- 1,555 new clients registered for NSES;
- 57 anonymous transactions completed.

Most of the transactions (4,296) within the NHSCT area were carried out by Community Pharmacy.




Figure 15: Gender of Clients at registration in NHSCT

The majority of new clients registered were male (87.1%).






Figure 16 reflects that of the 4,300 transactions in this reporting period, 4,955 reports of substance used were recorded across 19 substances. This includes those selecting the 'unknown' category at 1,510 (30.5%) of reports.


The largest recorded substance used in needle exchange was anabolic steroids (1,880), followed by heroin/morphine (833), followed by cocaine powder (265).

- 2,156 NSES transactions completed;
- 1,050 unique clients using NSES;
- 884 new clients registered for NSES;




Figure 19: Gender of Clients at registration in SEHSCT

The majority of new clients registered were male (89.8%).




Figure 20: Recorded Substance Used by transaction in SEHSCT

Figure 20 reflects that of the 2,156 transactions in this reporting period, 2,316 reports of substance used were recorded across 17 substances. This includes those selecting the 'unknown' category which was 1,583 times (68.4%).


Of those who did report, anabolic steroids (371) was the most reported substance followed by heroin/morphine (187), followed by cocaine (58).




Figure 23: Gender of Clients at registration in SHSCT

Figure 24: Recorded Substance Used by transaction in SHSCT




Figure 24 reflects that of the 1,243 transactions in this reporting period, 1,362 reports of substance used were recorded across 10 substances. This includes those selecting the 'unknown' category which was selected 537 times (39.4%).


The largest substance recorded was anabolic steroids (353) followed by heroin/morphine (231) and cocaine powder (103).

- 88 anonymous transactions completed.


Figure 25: Number of Transactions per provider type for WHSCT



Figure 28: Recorded Substance Used by transaction in WHSCT area





Figure 28 reflects that of the 2323, transactions in this reporting period, 1,760 reports of substance used were recorded across 22 substances. This includes those selecting the 'unknown' category which accounted for 682 reports (29.4%).

The largest recorded substance usage in needle exchange was anabolic steroids (1,101) followed by heroin/morphine (201) and tanning (195).


