

Speech, language and communication therapy action plan

Foreword

Welcome to the first update on the Speech, language and communication therapy action plan, which provides information on the progress made so far in its implementation.

Background

The action plan was developed by the Department of Health, Social Services and Public Safety (DHSSPS) with the aim that all children and young people at risk of or presenting with speech, language or communication needs will be able to benefit from timely support and integrated services that best meet their requirements.

The Public Health Agency (PHA), in partnership with the Health and Social Care Board (HSCB), has been tasked with implementing the action plan.

Progress

I am delighted with the progress made to date on the actions we have been set. A number of action points have been followed up, such as:

- promoting the early development of speech, language and communication through *Healthy child, healthy future: A framework for the universal child health promotion programme in Northern Ireland*;
- a one website approach to the online provision of speech and language therapy information.



We continue to work in a number of other areas, including the education sector. Page two provides further details of our progress.

Next steps

Engagement was integral to the development of the action plan and it is our aim that parents, carers and children help us carry out the remaining actions. I believe passionately in listening to and acting upon your views, and I hope many of you will respond to our invitation on page three.

I hope you enjoy this first update and look forward to keeping you informed as we deliver the necessary changes to improve services for children and young people with speech, language and communication needs in Northern Ireland.

What is the action plan?

Speech, language and communication are crucial in giving every child the ability to succeed in life. The ability to communicate is an essential life skill for all children and young people and underpins a child's social, emotional and educational development (Bercow report).

The *Speech, language and communication therapy action plan* was developed and agreed by a multi-agency project team established by the Department of Health, Social Services and Public Safety (DHSSPS) to drive improvements in partnership working between health and education, and to help support early identification of children's needs. The implementation of this action plan is led by the PHA and Health and Social Care Board (HSCB) through the project implementation team.

The aim of the action plan is that all children and young people at risk of, or presenting with, speech, language and communication needs will be able to benefit from timely support and integrated services that best meet their requirements.

Progress to date

The action plan is well underway, with work completed or ongoing in all areas. Through this work:

- the parent child health record has been amended to promote earlier identification of child development concerns;
- a model to standardise speech and language therapy (SLT) input into SureStart has been developed with recommendations for implementation;
- early development of speech, language and communication is being promoted by working with parents through *Healthy child, healthy future: A framework for the universal child health promotion programme in Northern Ireland*.



Work continues in the development of care pathways and a scoping exercise to determine the current provision of communication aids for children and young people.

We are also working with education authorities on the most effective ways to distribute awareness-raising materials in school settings and assessing how to collaboratively deliver appropriate training for qualified nursery, Year 1 and Year 2 teachers.
