Consultation is an important part of the development of the draft Corporate Plan 2025-2030 and we really want to hear your views on the plan.

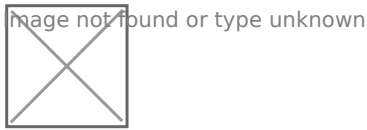
