Introduction

Respiratory infections are recognised as a preventable cause of severe morbidity and mortality in care home populations (Rainwater-Lovett et al., 2014). Transmission of influenza and other respiratory infections is increased in closed community settings such as care homes, due to increased susceptibility of the vulnerable population and the likelihood of increased transmission caused by close contact between residents and staff (Bridges, Kuehnert, & Hall, 2003). Flu vaccination of residents and staff is the most effective preventive measure against influenza (Talbot, Libster, & Edwards, 2012).

The 2018/19 flu season was characterised by lower levels of activity than those observed in previous years, there were 12 confirmed influenza outbreaks in Northern Ireland. Two thirds of these outbreaks occurred in care homes. Uptake of flu vaccination in health and social care workers (HSCWs) across Northern Ireland has been low over the years and the Chief Medical Officer (CMO) has highlighted the importance of increasing uptake rates.

All frontline HSCWs working in your care home for any period of time between 1 September 2019 and 31 March 2020 should be offered the flu vaccine at the earliest opportunity and by early December before flu generally starts to circulate. This includes bank and agency staff.

There are a number of ways care home staff can avail of the vaccine which are detailed in appendix 1. Further information can be found in the CMO policy letter, <u>'Seasonal influenza vaccination programme 2019/20'</u>.

Measuring uptake of flu vaccine in frontline HSCWs working in care homes

The Public Health Agency (PHA) is responsible for monitoring influenza vaccine uptake of frontline HSCWs on behalf of Department of Health (DoH). Currently the PHA publishes vaccine uptake for HSCWs from the five Health and Social Care (HSC) Trusts and the Northern Ireland Ambulance Service (NIAS).

The DOH has requested that the PHA better understands the percentage of the care home workforce vaccinated against influenza. As a result, the PHA flu surveillance team has developed this guidance to enable all care homes in Northern Ireland to collect data to determine the percentage of all frontline HSCWs vaccinated that are working/worked in care homes at any point between 1 September 2019 and 31 March 2020 (during the 2019/20 influenza season). The PHA flu surveillance team will use this data to determine vaccine uptake (see box below).

Vaccine Uptake of frontline HSCWs (%) =

No. working in care home that received vaccine at any time in 2019/20 (numerator) No. working in the care home at any time during 2019/20 (denominator)

The PHA is collecting data from care homes at two points in the season – December 2019 and March 2020 (end of season). The PHA piloted data collection in care homes during the 2018/19 influenza season and is encouraging all care homes to continue to participate this year, to support ongoing efforts to increase vaccine uptake in care home HSCWs.

Care homes should submit this information using the online data collection form (appendix 2) by the agreed collection deadlines to enable PHA to accurately monitor vaccine uptake.

The purpose of this guidance is to provide clear instruction to care homes on data collection requirements for the 2019/20 flu season, and thus ensure standardised data collection across all care homes.

Whilst care homes are likely to offer the flu vaccine to all staff, the PHA will only collect data on the number of frontline HSCWs vaccinated (as defined in this guidance).

This guidance includes information on:

- 1. definition of frontline health and social care workers (HSCWs)
- 2. identification of all staff eligible for the vaccine at the start of the season
- 3. collection of numbers throughout the season
- 4. online data collection form
- 5. data submission dates

At the end there are general questions and answers on common problems with recording the data.

Instructions

1. Categorise care home staff according to the following definitions

Frontline Health and Social Care Workers (HSCWs):

- provide health-related services and/or social care services in independent sector care homes that are in <u>direct contact with patients</u>
- Table 1 outlines the definitions that should be included in the data returns to the PHA

Non-frontline care home staff:

- any member of staff directly involved in the day-to-day running of the organisation and its infrastructure but not involved in direct patient care
- Table 2 outlines non-frontline staff that should NOT be included in the data returns

Care homes may need to use a degree of judgement for some staff members on whether or not to include (see FAQs for further information).

² The listed staff are considered non-frontline and therefore numbers do not need to be submitted to the PHA for monitoring purposes. However, you may wish to offer the flu vaccine to all staff that you employ. Judgement may also have to be used to determine whether any listed staff would be frontline in your organisation. Please see General Questions and Answers (page 10) for further information.

2. Identify all staff eligible for the vaccine at the start of the season

Care homes should identify the total number of frontline HSCWs in their home from the start of the season (1 September 2019). Whilst care homes may offer the vaccine to all employed staff, the PHA will only collect data on those that are defined as frontline HSCWs. This number is called the **'baseline denominator'**. Table 3 summarises the frontline HSCWs that should be included in the baseline denominator.

Each care home should send their baseline denominator to the PHA before the first reporting date (14 December 2019).

³ If accurate denominator data is known for frontline HSCWs that are <u>not employed directly</u> by the care home (e.g. students, agency/bank staff), please report this separately (see collection form in appendix 2).

3. Collecting numbers throughout the season

Care homes should collect and record the total number of frontline HSCWs employed by the home that have received the flu vaccine. This is called the '**numerator**'. Care homes should also update the baseline '**denominator**' to take into consideration frontline HSCWs who start work (starters) during the flu season, i.e. after 1 September 2019. Care homes should report both to the PHA. Table 4 clarifies individuals that should and should not be included in the numerator and denominator at both collection dates.

4. Data collection form

The PHA are asking care homes to collect and submit data on the number of frontline HSCWs vaccinated, using the online care home data collection form found at http://phaforms.hscni.net/care-home-form-collection-form/ (appendix 2).

5. Data collection submission dates

All care homes should complete the online care home data collection form found at <u>http://phaforms.hscni.net/care-home-form-collection-form/</u> (appendix 2) within the time frames outlined in table 5.

Once data is submitted by care homes, the PHA flu surveillance team will validate the data and query any possible anomalies. Uptake figures will be collated and reported at the end of the flu season. This information will be utilised to support ongoing efforts to increase vaccine uptake in care home HSCWs.

General questions and answers

Do I have to submit?

PHA will be collecting vaccine uptake data in frontline care home HSCWs between 1 September 2019 and 31 March 2020. Information collected will provide an understanding of the percentage of the care home workforce vaccinated against influenza. It will also enable appropriate development of resources and assistance in relation to improving vaccine uptake in care home HSCWs.

Why are we not collecting data for other support services such as those working in catering and domestic services?

The role of catering and domestic service staff across care homes differs, with some having direct patient contact and others not. It is therefore not possible to standardise data collection for these groups across all care homes and so a decision has been taken not to include these groups as frontline for PHA <u>monitoring purposes</u> <u>only</u>. However, in care homes where these staff are considered to have patient contact they should be offered the vaccine in the same way as other frontline staff.

Are we collecting data on clerical and administrative staff that work in care homes?

Administrative and clerical staff mostly do not have direct patient contact therefore the decision has been taken not to include any administrative and clerical staff as frontline for PHA <u>monitoring arrangements only</u>. However, in care homes where these staff do have patient contact they should be offered the vaccine in the same way as other frontline staff.

Why do you not remove leavers from the care home?

The information PHA is interested in is the number of frontline HSCWs that were vaccinated when they worked in the care home <u>at any point</u> during the flu season, even if this is only one day or shift. Even if the person leaves during the flu period they should still be captured in both the numerator and denominator.

Appendix 1 Methods of Vaccination

There are a number of methods by which care home staff can avail of the vaccine:

- Frontline independent sector (nursing and residential) care home staff can receive the vaccine via the Occupational Health Service in their local Trust. Details of the available clinics will be circulated by RQIA to all care homes before the start of the flu season.
- Staff in one of the recommended clinical risk groups can attend their GP for vaccination. Clinical risk groups identified for 2019/20 are detailed in the CMO policy letter, <u>'Seasonal influenza vaccination programme 2019/20'</u>.
- 3. Privately from community pharmacies.
- 4. Any other vaccination schemes that care homes as a provider, or agency employers, have in place to offer flu vaccination to the workforce.
