Section 1: Background

The Needle and Syringe Exchange Scheme (NSES) is vital to the health and wellbeing of the entire community, helping to reduce the potential of drug-related litter, lowering the risk of HIV and Hepatitis B and C within the wider population, and putting those who use the service in direct contact with a health professional who can help them in engaging with treatment services to address their drug use. Thirty-one needle exchange services are commissioned across Northern Ireland based in areas where there is an existing pattern of people who inject, but help protect everyone in the community. Anyone who injects substances can use a needle exchange service, and this includes people who inject opioids, steroids, tanning agents or stimulants.

Throughout 2022 PHA fully implemented a new online database to record needle exchange activity alongside anonymous, non-identifiable client data. This database is called the Neo360 Harm Reduction Information System and became fully operational across all NSES sites on 1 December 2022. This database permits live data to be accessed which in turn will allow for a timely and effective public health response to any detected trends.

This report summarises data that has been collated by Neo360 within the threemonth period between 1 April 2023 and 30 June 2023. Needle exchange activity was recorded in 28 active sites throughout this period. Three additional NSES sites did not record any NSES transactions during this period. One new site was commissioned this quarter, Queen's Quarter Housing in Belfast.

Within this reporting period 1,687 new clients registered to use the service, bringing the overall total of clients registered (since the online database was first phased into use on 11 July 2022) to 5,324 clients. This number is understood to be inflated due to the number of clients re-registering on the system mainly due to concerns regarding their anonymity, providers continually work with clients to try to keep this figure accurate and reassure clients that the data collated does not identify them.

In terms of unique client usage for the reporting period, there was a total of 4,163 unique clients across Northern Ireland for this reporting period. When this report is run per Trust area (as reported in individual trust reports) this totals 3293 unique service users which implies that 898 clients are crossing Trust boundaries to access multiple needle exchange services.

This report includes the regional data across Northern Ireland, followed by a breakdown per trust, **correct as of 1 July 2023**. The following information is collated:

- Total number of transactions;
- Transaction by provider type;
- Transaction by trust location;
- Age of client at registration;
- Gender of client at registration;
- Recorded substance/s used.


Section 2: Regional NSES Data Review

NSES Transactions

From April – June 2023 there were a total of **8,180 NSES transactions** carried out across Northern Ireland. This shows a reduction of 617 exchanges from the previous quarter.

Figure 1: Number of NSES transactions by Provider Type

Figure 1 reflects that the community-based providers completed 44.7% of the transactions for the period whilst the 20 community pharmacy sites completed over 52.2% of the transactions.






Figure 2: Number of transactions by each Health and Social Care Trust area

The highest number of overall transactions continue to take place in BHSCT area (69.2%) and the lowest percentage of transactions continue to take place in the SHSCT area (3.7%)

NSES User Profile





Figure 3: Current Age of new Clients registered in reporting period

The age and gender profile of the 1,687 users registered within the reporting period is shown in Figures 3 and 4.

The most common age category for new clients remains the same as previous quarter at 30-34 years, closely followed by those aged 35-39.

This pie chart reflects that the NSES is used primarily by males with 86.5% of registered clients in this quarter being male.

Figure 5 shows the gender breakdown by trust of clients registering for needle exchange this quarter. Western Trust area continues to reflect the largest number of female clients however overall this remains a male dominated service.




Recorded Substance Used

The graph below reflects the reported substances used by clients for each transaction. Clients may report more than one substance in response to this.

Figure 6 reflects that of the 8180 transactions in this reporting period, 8059 reports of substance used were recorded across 20 substances/categories with 1910 transactions deciding not to disclose substance used.

Figure 6: Reported substances used by transaction from 1 April 2023 to 30 June 2023



Heroin/morphine has the largest reported usage within needle exchange clients. Cocaine powder and anabolic steroids are the second and third most reported substances respectively, across the region.

Although heroin/morphine were reported most frequently during transactions, the number of unique clients using anabolic steroids by far exceeded those using heroin/morphine or cocaine.

Please see below a breakdown of the needles dispensed across all needle exchange sites for the reporting period. A total of 161,024 needles were dispensed across needle exchange in Northern Ireland.

Basic principles are that the shorter needles are used for surface vein injecting (arms, hand, feet etc), and the longer ones for deeper veins (legs and groin) and steroids which are intramuscular injections.

The 0.5ml and the 1ml Unisharp are the mainstay of all injecting equipment, they are the shortest and thinnest needles and also the lowest dead space syringes. It is positive from a harm reduction perspective these continue to be used frequently within needle exchange with 77,601 (48.2%) in total dispensed in the reporting period.

The highest dispensed single needles are blue (30mm) and green (40mm) with a total of 72,201 (44.9%) dispensed in the reporting period. These are the largest needles and are used for both groin injecting and steroid injecting.

Use of Foils

In promoting harm reduction, staff within needle exchange sites are encouraged to dispense foils which will support smoking, thus, reducing the harm caused through injecting. Fifteen sites dispensed foils this quarter with a total of 1688 packets (20 foils per pack) being distributed.

Returns


We have amended the system to record estimated needles returned as opposed to number of bins. This quarter 8948 estimated needles were returned within exchanges. This is a return rate of 5.5% of those needle dispensed.

Section 3: Belfast Health and Social Care Trust Area NSES Data

In the Belfast Health and Social Care Trust Area (BHSCT) within the reporting period there were:

- 5664 NSES transactions completed;
- 1579 unique clients using NSES; •
- 669 new clients registered for NSES;
- 168 anonymous transactions completed.

Within the BHSCT area 64.6% of transactions are completed by community providers.




Figure 8: Age of Clients at registration in BHSCT





Figure 9: Gender of Clients at registration in BHSCT

The age and gender profile of the 669 users registered within the reporting period is shown in Figures 8 and 9

The most common overall age group of new client in BHSCT was age 30-34 years.

The majority of new clients registered were male (85%).






Figure 10 reflects that of the 5664 transactions in this reporting period, 6450 reports of substance used were recorded with 16 substances/categories. The unknown option was selected within 839 transactions.

The largest recorded substance used in needle exchange was heroin/morphine followed by cocaine (powder) and anabolic steroids. All of which had significant increases in reporting since last quarter.

Section 4: Northern Health and Social Care Trust Area NSES Data

In the Northern Health and Social Care Trust Area (NHSCT) within the reporting period there were:

- 1032 NSES transactions completed;
- 692 Unique clients using NSES;
- 365 new clients registered for NSES;
- 5 anonymous transactions completed.

All transactions within the NHSCT area were carried out by Community Pharmacy.




Figure 11: Current Age of Clients in NHSCT registered in reporting period





Figure 12: Gender of Clients at registration in NHSCT

The age and gender profile of the 365 users registered within the reporting period is shown in Figures 11 and 12.

The most common overall age group of client in NHSCT was age 35-39 years.

The majority of new clients registered were male (88%).






Figure 13 reflects that of the 1032 transactions in this reporting period, 822 reports of substance used were recorded with 11 substances/categories and 349 transactions deciding not to disclose the substance used.


The largest recorded substance used in needle exchange was anabolic steroids (451), followed by heroin/morphine (210), followed by Cocaine powder. This remains the same from previous quarter.

Section 5: South-Eastern Health and Social Care Trust Area NSES Data

In the South Eastern Health and Social Care Trust Area (SEHSCT) within the reporting period there were:

- 561 NSES transactions completed;
- 394 unique clients using NSES;
- 240 new clients registered for NSES;
- 7 anonymous transactions completed.





Figure 15: Current Age of Clients in SEHSCT registered in reporting period

The age and gender profile of the 240 users registered within the reporting period is shown in Figures 15 and 16.

Figure 17: Recorded Substance Used by transaction from 1 April 2023 to 30 June 2023 in SEHSCT





Figure 17 reflects that of the 561 transactions in this reporting period, 156 reports of substance used were recorded across 7 substances/categories with a 422 transactions (72%) deciding not to disclose the substance used. Of those who did report anabolic steroids was the most reported substance followed by morphine/heroin (43), followed by cocaine powder.

Section 6: Southern Health and Social Care Trust Area NSES Data

In the Southern Health and Social Care Trust Area (SHSCT) within the reporting period there were:

- 303 NSES transactions completed;
- 206 unique clients using NSES;
- 122 new clients registered for NSES;
- 15 anonymous transactions completed.





Figure 19: Current Age of Clients in SHSCT registered in reporting period

The age and gender profile of the 142 users registered within the reporting period is shown in Figures 19 and 20.

Figure 21: Recorded Substance Used by transaction from 1 April 2023 to 30 June 2023 in SHSCT




Figure 21 reflects that of the 303 transactions in this reporting period, 163 reports of substance used were recorded with 7 substances/categories. The unknown category was selected 137 times. The largest substance recorded was anabolic steroids (86) followed by morphine/heroin (29) and an equal amount for tanning and cocaine powder (13)

Section 7: Western Health and Social Care Trust Area NSES Data

In the Western Health and Social Care Trust Area (WHSCT) within the reporting period there were:

- 620 NSES transactions completed;
- 422 unique clients using NSES;
- 291 new clients registered for NSES;
- 15 anonymous transactions completed.

All of these transactions were completed by Community Pharmacies.

NSES User Profile

The age and gender profile of the 291 users registered within the reporting period is shown in Figures 23 and 24.




Figure 22: Current Age of Clients in WHSCT registered in reporting period

Overall the most common age category in the WHSCT area was 35-39 years.





Figure 23: Gender of new Clients at registration in WHSCT

The majority of clients were male (85%) within the WHSCT area.







Figure 24 reflects that of the 620 transactions in this reporting period, 468 reports of substance used were recorded with 12 substances/categories. 163 transactions selected the unknown category.

The largest recorded substance usage in needle exchange was anabolic steroids followed by tanning and heroin/morphine. The WHSCT area remains the are reporting largest number of transactions with tanning solution. This has increased from 23 last quarter to 48 this quarter.
