Section 1: Background

The Needle and Syringe Exchange Scheme (NSES) is vital to the health and wellbeing of the entire community, helping to reduce the potential of drug-related litter, lowering the risk of HIV and Hepatitis B and C within the wider population, and putting those who use the service in direct contact with a health professional who can help them in engaging with treatment services to address their drug misuse. Thirty-two needle exchange services are commissioned across Northern Ireland based in areas where there is an existing pattern of people who inject, but help protect everyone in the community. Anyone who injects substances can use a needle exchange service, and this includes people who inject opioids, steroids, tanning agents or stimulants.

Throughout 2022 PHA fully implemented a new online database to record needle exchange activity alongside anonymous, non-identifiable client data. This database is called the Neo360 Harm Reduction Information System and became fully operational across all NSES sites on 1 December 2022. This database permits live data to be accessed which in turn will allow for a timely and effective public health response to any detected trends.

This report summarises data that has been collated by Neo360 within the three-month period between 1 July 2023 and 30 September 2023. Needle exchange activity was recorded in 30 active sites throughout this period. Two additional NSES sites did not record any transactions during this period. Foyle Haven, a Low Threshold Service in the Western Trust area opened a needle exchange this quarter.

Within this reporting period 1,407 new clients registered to use the service, bringing the overall total of clients registered (since the online database was first phased into use on 11 July 2022) to 6,731 clients. This number is understood to be inflated due to the number of clients re-registering on the system due to fears regarding their anonymity, providers continually work with clients to try to keep this figure accurate.

In terms of unique client usage for the reporting period, there was a total of 3,109 unique clients across Northern Ireland. When this report is run per Trust area this totals 3,318 unique service users which implies that 209 clients are crossing Trust boundaries to access multiple needle exchange services.

This report includes the regional data across Northern Ireland, followed by a breakdown per trust, **correct as of 1 October 2023**. The following information is collated:

- Total number of transactions;
- Transaction by provider type;
- Transaction by trust location;
- Age of client at registration;
- Gender of client at registration;
- Recorded substance/s used.

Section 2: Regional NSES Data Review

NSES Transactions

From July to September 2023 there were a total of **7,925 NSES transactions** carried out across Northern Ireland. The first quarter (January to March 2023) reported 8,797 transactions, the second quarter (April to June 2023) reported 8,180 transactions. Transactions have reduced each quarter this year however the amount of needles dispensed continues to increase each quarter.

Figure 1: Number of NSES transactions by Provider Type

Figure 1 reflects that the community pharmacies completed 50.3% of the transactions for the reporting period. The community-based providers transactions have decreased slightly from the previous quarter, although they still completed over 45.5% of the total transactions.




Figure 2: Number of transactions by each Health and Social Care Trust area

The highest number of overall transactions continue to take place in BHSCT area (66.4%) and the lowest percentage of transactions continue to take place in the SHSCT area (4.3%).





Figure 3: Current Age of new Clients registered in reporting period


Figure 4: Gender of Clients at registration

The age and gender profile of the 1,407 users registered within the reporting period is shown in Figures 3 and 4.

The most common age category for new clients remains the same as previous the quarter at 35-39 years, followed by those aged 30-34.

Figure 5 shows the gender breakdown by trust of clients registering for needle exchange this quarter. Western Trust area continues to reflect the largest number of female clients however overall this remains a male dominated service.




Recorded Substance Used

The graph below reflects the reported substances used by clients for each transaction. Clients may report more than one substance in response to this.

Figure 6 reflects that of the 7,925 transactions in this reporting period, 9,640 reports of substance used were recorded across 23 substances. This includes those selecting the 'unknown' category which remain high at 2062 (21.4%) and this increased by 152 transactions this quarter.

Figure 6: Reported Substances Used by Transaction



Heroin/morphine (2,419) has the largest reported usage within needle exchange clients. Cocaine powder (2,084) and anabolic steroids (1,858) are the second and third most reported substances respectively, across the region.

Although heroin/morphine were reported most frequently during transactions, the number of unique clients using anabolic steroids by far exceeded those using heroin/morphine or cocaine.

Please see below a breakdown of the needles dispensed across all needle exchange sites for the reporting period. A total of 179,161 needles and syringes combined were dispensed across needle exchange in Northern Ireland.

Basic principles are that the shorter needles are used for surface vein injecting (arms, hand, feet etc), and the longer ones for deeper veins (legs and groin) and steroids which are intramuscular injections.

The 0.5ml and the 1ml Unisharp are the mainstay of all injecting equipment, they are the shortest and thinnest needles and also the lowest dead space syringes. It is positive from a harm reduction perspective these continue to be used frequently within needle exchange with 86,238 (48%) in total dispensed in the reporting period.

NSES dispenses a 2ml starter pack and 2ml standard pack, 1,392 were dispensed in the reporting period, however, these do not contain needles. Clients then select needles separately, accounting for the high number of single coloured needles dispensed. The highest dispensed single needles are blue (30mm) 42,167 dispensed and green (40mm) 39,738 dispensed with a total of 81,905 (45.7%) dispensed in the reporting period. These are the largest needles and are used for both groin injecting and also for steroid injecting.

The number of needles dispensed continues to increase each quarter. From January to March 2023 158,296 needles were dispensed, April to June 2023 161,024 were dispensed and from July to September 2023 179,161 were dispensed. The total needles dispensed in this calendar year thus far is 498,491.

Use of Foils

In promoting harm reduction, staff within needle exchange sites are encouraged to dispense foils which will support smoking, thus, reducing the harm caused through injecting. Sixteen sites dispensed 1,296 packets (20 per pack).

Returns


We have amended the system to record estimated needles returned as opposed to number of bins. This quarter 23,336 estimated needles were returned within exchanges. This is a return rate of 13%. This is a large increase from last quarter (8,948 recorded last quarter). This could be down to further clarity regarding recording returns on the system as well as some known larger interventions coordinated through low threshold services which included assistance with returns.

Section 3: Belfast Health and Social Care Trust Area NSES Data

In the Belfast Health and Social Care Trust Area (BHSCT) within the reporting period there were:

- 5,264 NSES transactions completed;
- 1,524 unique clients using NSES;
- 525 new clients registered for NSES;
- 150 anonymous transactions completed.

Figure 7: Number of Transactions per Provider Type in BHSCT




Community based providers remain to be completing the highest volume of transactions (68.5%) for the BHSCT.



Figure 10: Recorded Substance Used by transaction in BHSCT




Figure 10 reflects that of the 5,264 transactions in this reporting period, 6,729 reports of substance used were recorded across 17 substances. This includes those selecting the 'unknown' category which was 883 (13.1%).

The largest recorded substance used in needle exchange was heroin/morphine (2,031) followed by cocaine powder (1,967) and anabolic steroids (873).

Section 4: Northern Health and Social Care Trust Area NSES Data

In the Northern Health and Social Care Trust Area (NHSCT) within the reporting period there were:


- 1,135 NSES transactions completed;



Figure 13: Recorded Substance Used by transaction in NHSCT




Figure 13 reflects that of the 1,135 transactions in this reporting period, 1,279 reports of substance used were recorded across 12 substances. This includes those selecting the 'unknown' category which remains very high at 411 (32.1%) of reports.


The largest recorded substance used in needle exchange was anabolic steroids (518), followed by heroin/morphine (208), followed by cocaine powder (46). This remains the same from previous quarter.

Section 5: South-Eastern Health and Social Care Trust Area NSES Data

In the South Eastern Health and Social Care Trust Area (SEHSCT) within the reporting period there were:

- 558 NSES transactions completed;
- 403 unique clients using NSES;
- 189 new clients registered for NSES;
- 2 anonymous transactions completed.

The most common overall age group of clients in SEHSCT was age 30-34 years.





Figure 16: Gender of Clients at registration in SEHSCT

Figure 17 reflects that of the 558 transactions in this reporting period, 595 reports of substance used were recorded across 13 substances. This includes those selecting the 'unknown' category which was 412 times (74%).


Of those who did report anabolic steroids (96) was the most reported substance followed by morphine/heroin (51), followed by cocaine powder (10).




Figure 20: Gender of Clients at registration in SHSCT

The majority of new clients registered were male (86%).




Figure 21: Recorded Substance Used by transaction in SHSCT

Figure 21 reflects that of the 339 transactions in this reporting period, 378 reports of substance used were recorded across 9 substances. This includes those selecting the 'unknown' category which was selected 179 times (47.4%).

The largest substance recorded was heroin/morphine (66) followed by anabolic steroids (66) and cocaine powder (31).




Figure 22: Number of Transactions per provider type for WHSCT



Figure 25: Recorded Substance Used by transaction in WHSCT area





Figure 25 reflects that of the 629 transactions in this reporting period, 658 reports of substance used were recorded across 15 substances. This includes those selecting the 'unknown' category which accounted for 177 reports (26.8%).

The largest recorded substance usage in needle exchange was anabolic steroids (305) followed by heroin/morphine (54) and tanning (51).
