Introduction of MMRV

Following review of the latest evidence the Joint Committee for Vaccination and Immunisation have recommended Measles, Mumps, Rubella and Varicella (MMRV) vaccination as part of the routine childhood immunisation schedule.

From 1st January 2026, MMRV will be offered to eligible children in accordance to their date of birth and the introduction of a new 18 month appointment.

The MMR vaccine should no longer be used as part of the routine immunisation schedule.

Child Health System will schedule all eligible children for vaccination, GP practices will receive clinic sheets detailing which vaccines to provide.

What's changing in the Routine Programme

Children born on or after 1 January 2025:

- 2 doses of the new MMRV vaccine
- first at 12 months
- second at 18 months

Children born from 1st July 2024 to 31st December 2024:

- MMR at 12 months
- then MMRV at 18 months
- and again at 3 years 4 months

Children born on or after 1st September 2022 to 30th June 2024:

- 1 dose of MMRV at 3 years 4 months (instead of MMR)

Selective MMRV catch-up programme

Between November 2026 and March 2028, children aged 3 years 4 months to under 6 years (Children born on or after 1st January 2020 to 31st August 2022) without a history of chickenpox disease or 2 doses of varicella vaccine will be offered one dose of MMRV.

Operational details as to how this programme will roll out will follow in due course.

New publications

A suite of new PHA public facing leaflets and professional resources have been developed to support the changes to the childhood schedule.

Child Health have received copies of all public facing leaflets, and a small supply will go to GP practices along with professional resources over the coming weeks..

Public information leaflets will be translated into 14 languages including BSL and ISL available on the PHA website. QR code and links to the online versions are available on page 3.



Webinars

Educational webinars for both clinical and administrative staff have taken place in December in conjunction with GPNI and the Clinical Education Centre. PCHR red book insert

Due to the changes, the vaccinations record table contained within existing Personal Child Health Record books (PCHR or "Red Book") will not reflect the current schedule. GP practices will receive new insertable sheets to replace the existing pages. Further instructions will be included along with the delivery.

Changes to the childhood schedule

MMRV Vaccines ordering and use

Available vaccines: Two MMRV vaccines are supplied as part of the routine childhood immunisation programme - ProQuad® and Priorix-Tetra®. They are clinically equivalent, interchangeable, and are the only MMR-containing vaccines used in the childhood programme.

Preferred product: ProQuad® is the first-line vaccine for all MMRV vaccinations, Priorix-Tetra® should only be ordered when a porcine gelatine-free option is required.



Ordering process: MMRV vaccine stock should be ordered through the usual channels and standard childhood vaccine ordering procedures. Do not order more than TWO weeks of vaccine stock in advance.

Storage requirements: MMRV vaccines must be stored in a vaccine refrigerator between +2°C and +8°C. For any cold-chain breaches - refer to the SPPG/PHA guidance on vaccine storage and handling in GP practices.

MMR vaccine stock: Whilst MMR vaccine stock remains available, it is not part of the routine childhood programme. It should only be used for eligible adults and older children who are not eligible for MMRV. Please refer to the

incomplete immunisation algorithm for guidance.

Varicella vaccine: The single-product varicella vaccine is not included in the routine childhood immunisation programme.

Important note on Priorix-Tetra packaging:

Please be aware that the packaging of Priorix-Tetra may cause confusion. The black box on the carton states "1 dose 0.5 mL", which can be misinterpreted in two ways:


- Stock management risk: Vaccinators may assume the pack contains only a single dose, potentially leading to unnecessary over-ordering and stock wastage.
- Administration risk: There is also a risk of overdose if vaccinators mistakenly believe that all 10 pre-filled syringes together represent one single dose, rather than 10 individual doses.

Practices are advised to ensure vaccinators and admin staff are briefed on this packaging issue to avoid errors in ordering and administration. Please remember 1 pack of Priorix-Tetra contains 10 doses.
