Again the emphasis on community based work is to be welcomed since research and experience of the project have shown this to be vital, particularly from the prevention and community service point of view. The challenge will be in funding the required work and the process of procurement that will have to follow this framework, and how the wide service specifications will be combined to allow community based projects to apply to continue the successful work we have been doing. To implement this framework in full it will cost money, and it remains to be seen if the document is underpinned by the finances to make it work in reality rather than as an aspiration.
