# **CLARE MC GARTLAND MBE**

Lead AHP Consultant, Public Health Agency (PHA)

Clare McGartland MBE is the lead Allied Health Professions (AHP) Consultant within the Public Health Agency. She leads a team of five AHP Consultants who provide professional input into both local and regional commissioning. She is based in the WEST commissioning office and is the AHP representative on the Local Commissioning Group.

Clare has previously worked as AHP Commissioner for the Western Health & Social Services legacy Board and had responsibility to commission services for a range of AHP professions. During this time she was appointed by the Privy Council to represent Orthoptics on the UK wide formation of a new AHP regulatory body – the Health Professions Council.

Clare is currently Chair of the Northern Ireland Lymphoedema Network.

In 2012, Clare was awarded an MBE in recognition for her services to Health Care in N Ireland.
