
Project Level Impact



Technology Making Life Better for Stroke Patients



VC for Speech & Language Therapy

- SLT (Daisy Hill) video conferencing post stroke patients at home or in Kilkeel Health Centre
- Operational between Sept 2013 Mar 2015
- From a Speech and Language Therapist's perspective the service has resulted in:
 - More intensive therapy to patients
 - Improved clinical outcomes
 - Shorter clinical sessions where appropriate
 - Reduced significantly travel time and costs
 - Increased clinical capacity
 - Increased response times to new referrals due to increased capacity
- Feedback from patient using the system three times a week.
 "It's easy to use and I can have more sessions to help with my recovery,"
- Trust looking at opportunities to use this more effectively in the future

Types of EU funding

- H2020 Research & Innovation 100% funding
- 3rd Health Programme annual thematic calls matched funding required (40%)
- Interreg funding stimulate cooperation between regions in the European Union
 - Interreg VA (85%, matched funding from Govt) Cross border Territorial Cooperation (Ireland/Northern Ireland/Western Scotland)
 - Interreg VB (40% matched funding)
 - Northern Periphery & Arctic Programme
 - North West Europe Programme
 - Atlantic Area Programme
 - Interreg IVC Europe four thematic platforms for regional and local public authorities to exchange practices and ideas on the way public policies work, and find solutions to improve their strategies for their own citizens.
